Whereas the Government of Andhra Pradesh have appointed by G.O. Ms. No. 86, Social Welfare (CV) Department, dt: 15.11.2024 a Commission of Inquiry headed by Sri Rajiv Ranjan Mishra, IAS (Retired) to enquire into the sub-classification within Scheduled castes in the light of Judgment of the Hon'ble Supreme Court (State of Punjab & Ors. Vs Davinder Singh & Ors. (Civil Appeal No.2317 of 2011), dated: 01.08.2024:

2. Now, therefore this notification is issued by and under the orders of the aforesaid Commission inviting all persons acquainted with the subject matter of the inquiry to furnish to the Commission, duly signed Memoranda / Representations containing statement of facts on the said subject matter as to which they are competent to depose.

- 3. The Commission will examine:
  - a) Inadequacy of representation among various sub-groups within Scheduled Castes in the Service of the State and admissions into Educational Institutions;
  - b) The social, economic, political and educational backwardness among various sub-groups within Scheduled Castes.

4. The Memoranda / Representations must be strictly confined to such subject matter and the statements of facts must be expressed to be relative to the particular item of the same. Such facts must be properly verified and furnished.

5. Every person furnishing a statement shall also furnish to the Commission along with the statement a list of the documents, if any, on which he proposes to rely and forward to the Commission, wherever practicable, the originals or true copies of such of the documents as may be in his possession or power and shall state the name and address of the person from whom the remaining documents may be obtained.

6. The original Memoranda / Representations with one copy of each must be filed on any working day between hours 10.00 AM and 5.30 PM, against receipt therefor from the office or sent by Registered post acknowledgement due on or before 9<sup>th</sup> January, 2025. Memoranda / Representations not verified in the manner indicated above or not filed within the dates or in the manner specified above will not be taken into consideration by the Commission unless special reasons are shown.
